Michigan Prosecutors Join Panel Talk on Racial Bias and Misdemeanors

Ingham, Washtenaw prosecutors join panel talk after documentary viewing

LANSING — On **Monday, Sept. 20, at 7 p.m.**, please join Safe & Just Michigan and a panel of experts on our criminal legal system for an **online screening** of <u>Brave New Films</u> short documentary, *Racially Charged: America's Misdemeanor Problem*. The discussion following the event will feature **Ingham County Prosecutor Carol Siemon** and **Washtenaw County Prosecutor Eli Savit**.

Narrated by Oscar-winning actor **Mahershala Ali**, *Racially Charged* illustrates how the U.S. misdemeanor system — today, as in the post-Civil War era — disparately impacts marginalized communities. The film features powerful testimony from people today who have paid enormous prices for minor infractions, presented in stark parallel with accounts of formerly enslaved people targeted by the Black Codes 150 years ago. Inspired by Harvard Law professor **Alexandra Natapoff**'s book, *Punishment Without Crime*, the film offers urgent insights, compelling testimony, and critical historical context to the issues animating today's Black Lives Matter and criminal justice movements.
